# GREENE COUNTY PUBLIC HEALTH MONTHLY ACTIVITY REPORT April 21, 2025

### 1. Foundational Capabilities

#### a. Administration

- i. Respiratory season has calmed down, and spring has arrived, along with ticks and allergy season. Health districts will educate and inform the public on how to protect themselves against tick bites and diseases such as Lyme disease.
- ii. Legislative update: State Senator Kyle <u>Koehler</u> (R-Springfield) currently serves on the Senate Agriculture and Natural Resources, Education, Higher Education, Local Government, and Workforce Development Committees. State House Representative Brian <u>Lampton</u> serves on the House Insurance, Medicaid, Small Business, Veterans, and Military Development Committees. He Chairs the Insurance Committee. State House Representative Levi <u>Dean</u> serves on House Agriculture, Commerce and Labor, Development, and Small Business Committees.
  - i. The House has approved their version of the budget bill including amendments prohibiting the Ohio Department of Health (ODH) director from adopting rules requiring a soil evaluator or soil scientist to evaluate the soil type and slope with respect to a household sewage treatment system; requiring the county coroner to be appointed by the Board of County Commissioners instead of being elected; and language to remove the County Prosecutor from the Budget Commission and makes the President of the Board of County Commissioners a member of the Budget Commission instead.
    - 1. <u>HB 10</u> (Klopfenstein, Daniels) Regulates imitation meat and egg products in school lunches so that no lab meat is included in school lunches. In House Agriculture Committee.
    - 2. HB 28 (Mathews, Hall) Eliminates the authority to levy replacement property tax levies. The bill mandates that all ballot questions related to tax levies in excess of the ten-mill limitation be presented clearly with specific formatting and removes the option to renew or replace taxes for current operating expenses or permanent improvements. Legislation is co-sponsored by Representative Dean. Legislation has passed in the house.
    - 3. <u>HB 57</u> (Jarrells, Williams) Regards school policies on administering overdose reversal drugs including safety, security, training, and storage. Schools can accept monetary donations to support but does not specify partnering with local health districts to provide Narcan through existing supplies. Provides district and parent notification and schools would need to report trends in use. It would be helpful to provide notification to health districts.
    - 4. <u>HB 126</u> (Mathews A., Craig) Prohibits certain public nuisance actions. Legislation is regarding marketing and distribution of opioids





and lawsuits filed against pharmaceutical companies. In House Judiciary Committee.

- 5. <u>HB 137</u> (Lorenz) Permits tax authority to decline submitting certain levy to voters. Health districts and libraries have levies approved by the County Commissioners as taxing authorities and this legislation changes the language from "shall" to "may" place a levy on the ballot. Since health districts receive no funding from County Commissioners, the Commissioners could hear the request and decline to place a health district or library levy on the ballot. In House Local Government committee with no co-sponsors.
- 6. <u>HB 160</u> Liquor and Cannabis (Stewart, B.) To revise specified provisions of the liquor control, hemp, and adult-use marijuana laws and to levy taxes on marijuana.
- 7. <u>HB 162</u> Medical Records (Click, G) Relates to medical records of minors and to name the act the My Child-My Chart Act.
- 8. <u>HB 182</u> Public Water Systems (Dean, L) To prohibit a public water system from adding fluoride to its water.
- 9. <u>HB 198</u> Hemp (Fischer, T) To regulate the manufacture, distribution, and sale of inhalable and ingestible hemp products.
- 10. <u>HB 215</u> Property Tax Levies (Jarrells, D, Stephens, J)
- SB 69 (Romanchuk) Intends to reform the state's public retirement system law. In Senate Financial Institutions, Insurance and Technology Committee.
- 12. <u>SB 78</u> (Hicks-Hudson, DeMora) Establish and operate the Ohio Health Care Plan universal health care.
- 13. <u>SB 86</u> (Huffman, Wilkin) Regulate and tax intoxicating hemp, drinkable cannabinoid product
- 14. <u>SB147</u> (Reineke) Revise solid waste and construction and demolition debris laws. Has passed the Senate and was introduced in the house.
- b. Epidemiology
  - Measles. The percentage of Ohio kindergarteners who are up-to-date on all recommended vaccines continues to fall, an alarming development in light of the serious measles outbreak in Texas and New Mexico, the state's health director, Dr. Bruce Vanderhoff, said during a Tuesday press conference (Source: "<u>Ohio kindergarten vaccination rates drop amid measles outbreak concerns</u>," Cleveland Plain Dealer, March 18).


The percentage of Ohio kindergarteners who are up to date on all recommended vaccines is 85.4% for the 2024-25 school year, down from 86.2% in the previous year, he said. The percentage of Ohio students who were up to date on the measles, mumps and rubella (MMR) vaccine dropped from 89.2% in the 2023-24 school year to 88.3% in this most recent school year.

Those state-wide numbers are lower than the state's MMR vaccination rate of 92.5% for the 2019-2020 school year, and the national rate of 92.7% in the 2023-24 school year, Vanderhoff said.









ii. There are ways to reduce barriers to vaccination and respectfully listen to questions and concerns about getting a child vaccinated. As reported in the Greene County Community Health Assessment, cost is a barrier for residents to access care. The resident may lack insurance, have limited coverage or lack transportation to a vaccination site. Offering vaccines in schools, pharmacies and workplaces or after hours are convenient ways to address barriers. Providing information and education about vaccines from trusted knowledgeable sources can help address questions and concerns. Health districts also make the same recommendations for the routine <u>schedule</u> of vaccines to maximize protection from disease.

## b. Emergency Preparedness

- PHEP FY25 Grant Update
  - a. Ten out of eighteen deliverables are complete and approved.
  - b. Fifteen out of eighteen deliverables paid (\$104,783.00 out of \$121,841.00).
  - c. One deliverable approved will be billed in May (\$6,092.00).
  - d. Two deliverables left to submit.

#### **3.** Environmental Health (EH)

i.

- a. Food Establishment/Food Service
  - The ServSafe Manager certification courses for 2025 began this month. The first class was taught on April 14 and April 21, 2025, by R. Schairbaum and M. Fischer The other 2025 ServSafe classes will be taught in June, August, and October. Person-in-charge (PIC) training classes will be taught upon request by food operations.
  - ii. All operating food service operations (FSO), retail food establishments (RFE), and food vending locations have been licensed for the 2025 food licensure year. All food operations that did not renew their license by March 3, 2025, were assessed a 25% penalty fee.
  - iii. The Ohio Department of Agriculture (ODA) conducted our RFE survey exit meeting with S. Adams and R. Schairbaum on March 31, 2025. We should receive the official survey report from ODA within 45 calendar days.
  - iv. The festival season began this month, beginning on April 25, 2025, with Wright State University (WSU) April Craze, Vintage Market Days, and the Bellbrook Sugar Maple Festival. The EH team will report festivals and events inspected in the monthly activity report.





#### Mosquito

- i. Preparations for the upcoming mosquito season have begun, and we will contract with a trapping technician for the mosquito program. This position is financed by the 2025 Ohio Environmental Protection Agency (EPA) Mosquito Control Grant, which was awarded to GCPH again this year.
- c. Private Water Systems
  - i. J. Gruza and C. Kessler attended the "Test Your Well Event" again this year and answered residents' questions. They reported that the event well, and several residents called afterward to inquire about water testing.

#### d. Rabies

- i. New procedures were established for responding to bites and exposures in the program. From this point forward, all biting animal owners will be referred to their veterinarians for observation and vaccination boosters before being released from quarantine. This will save hundreds of Full-Time Equivalent (FTE) hours that can be devoted to other programs while providing incentives for pet vaccinations.
- e. Sewage i.
  - Three properties have been accepted for Water Pollution Control Loan Fund (WPCLF) funding for sewage repairs. One mound system is a carryover from last year since we depleted the funds. We have \$150,000 this year and have about two-thirds of the funding allocated to accepted projects this year.
- f. Swimming Pools/Spas
  - i. License renewals for public swimming pools/spas and RV campgrounds for the 2025 licensure year are ongoing.
  - K. Ray and M. Straight have worked together on the 2025 swimming pool/spa course to be taught at GCPH on April 30, 2025. Flyers for this course were mailed to our licensed pools and posted on social media. This course is designed to instruct commercial pool operators in the basics of swimming pool/spa operations, water chemistry, pump specifics, etc.

#### 4. Health Education

- *a. Creating Healthy Communities (CHC)* 
  - i. Interviews for the Community Ambassador position are underway and are being conducted this month.
  - ii. Farmers' Market Vendor Application QR codes have been distributed throughout the county to various agencies to increase vendor applications. The vendor application, previously due April 15, 2025, has been extended to April 30, 2025.
  - iii. A WSU public health student interviewed L. Gonyer on April 15, 2025, regarding healthy eating and active living efforts in Greene County and the Creating Healthy Communities/Healthy Eating and Active Living (HEAL) grant.
  - iv. L. Gonyer distributed food council flyers on April 16, 2025.
  - v. L. Gonyer collaborated with Miami Valley Regional Planning Commission (MVRPC) to create a Food Access Map for Greene County. This is an expansion of the Food Access Map created for the City of Fairborn during the HEAL grant. The draft map is being presented to the Greene County Food Council on April 24, 2025, for feedback.





- vi. The Greene County Food Council will have its third meeting on April 24, 2025. The meeting will focus on creating group objectives and goals and reviewing the Greene County Food Access Map.
- vii. The Creating Healthy Communities grant continuation is due on May 5, 2025.
- b. Harm Reduction
  - i. The Harm Reduction team participated in the Color Walk at the Xenia YMCA on April 5, 2025.
  - ii. K. Day and C. Holley-Wolf tested for human immunodeficiency virus (HIV), hepatitis-c (HCV), and syphilis at Bridges of Hope on April 9, 2025.
  - iii. The new Mobile Health Unit was delivered to GCPH. The mobile unit was paid for by the One Ohio Recovery Grant on April 15, 2025.
  - iv. K. Warren tabled at the Greene County FISH Food pantry in Xenia on April 17, 2025.
  - v. K. Warren and C. Holley-Wolf tabled at the Wright-Patt Safety Fest on April 30, 2025.
- c. Safe Communities
  - i. Attended the Advocacy Through Art event on April 5, 2025, to distribute Safe Communities items and educational materials and allow attendees to use the impairment goggles.
  - The 2025 Spring Seat Belt Challenge was conducted between local high schools. Three of the eight local high schools increased their students' seat belt scores, with Xenia High School increasing the belted students by 12.1% since Fall 2024. The Greene County Career Center won the Spring Seat Belt Challenge, with 95.5% of its students belted. This is the first seat belt challenge the Career Center has won since the Spring of 2014. In second place, Bellbrook High School had 92.1% of its students belted; in third place, Xenia High School had 91.2% of its students buckled.
  - iii. L. Gonyer and the Ohio State Highway Patrol reviewed vehicle fatalities in Greene County between January and March. There were three fatalities between January and March, and these were reported to local media in April.
  - Ten Drive to Succeed scholarships have been awarded to local teenagers this year.
    C. Edwards was interviewed on April 18, 2025, by ABC 22 Fox 45 regarding this program.
  - v. The Greene County Safe Communities Coalition met on April 16, 2025, to share Safe Communities updates, have a fatal review and share public updates on traffic safety.
  - vi. GCPH has the opportunity to apply for the FY2026 Safe Communities grant for \$46,200, a \$7,700 increase from the FY2025 award. The grant application is due on May 15, 2025.
  - vii. Planning for the 2025 Central State University (CSU) Mocktail Challenge begins on April 22, 2025. State Farm (Rick Kolmin) has already offered a donation of \$150 in gift cards for Mocktail Challenge winners.
  - viii. L. Gonyer met with Dayton Children's Hospital/Safe Kids Dayton on April 22, 2025, to share information regarding the Safe Communities grant and our initiatives.
  - ix. L. Gonyer attended Xenia High School's Mock Crash on April 24, 2025, and held a Drive Sober or Get Pulled Over banner signing with students.





- x. L. Gonyer and K. Warren attended Yellow Spring's Celebrate Trails Day on April 26, 2025.
- xi. L. Gonyer attended the Arrive Alive Tour, offered through the Safe Communities grant, at Beavercreek High School on April 29, 2025.
- xii. L. Gonyer attended the Wright-Patt Air Force Base Safety Fest on April 30, 2025.
- d. Tobacco
  - i. S. Hill and several other community partners presented the Color Walk and Health Fair on April 5, 2025, at the Xenia YMCA. Over 100 people attended the event.
  - ii. S. Hill met with Anew Behavioral Health on April 9, 2025, to discuss and update the facility's Tobacco Policy.
  - iii. On April 16, 2025, S. Hill met with and trained two helpers to complete tobacco compliance checks.
  - iv. On April 22, 2025, S. Hill will begin tobacco compliance checks across the county. Compliance checks ensure that retailers follow the law and do not sell tobacco products to anyone under 21.

## 5. Maternal Child Health (MCH)

- a. Communicable Disease & Tuberculosis (TB)
  - i. GCPH is now part of a health information exchange called CliniSync. There are 151 Ohio hospitals connected to CliniSync. This will improve and expedite the coordination of patient care.
- b. Early Childhood Home Visiting (ECHV)
  - i. All team members in ECHV, Healthy Families America (HFA), and Nurse-Family Partnership (NFP) have full caseloads. There is no waitlist, and new families are being accepted into these programs.
  - ii. C. Manor will attend the Growing Great Kids (GGK) Preschool training course in May. After this training, we can serve families for three years, per the Ohio Revised Code (ORC), up to age five.
- c. Early Intervention (EI)
  - i. Activities have begun to happen for the SFY26 EI grant. The first of which Family and Children First designated and approved GCPH to continue to be the administrative agent for the EI grant for SFY26. We are watching the state budget as it moves through legislation. There are no cuts in the EI line item, but an increase for SFY26 and SFY27 is currently designated in the state budget narrative directed to the local Board of DDs. The narrative states that the increase will assist the Boards in evaluation costs; we will continue to watch it closely. Since the new rules were released, DCY/Early Intervention has provided additional guidance in several areas over the last few months. Pam and Four Oaks Managers have been meeting more frequently to update and streamline local procedures and protocols for staff.
  - ii. T. Robertson has contacted 21 childcare centers over the past month and conducted one presentation. One of the highlights of being more active in the community is hearing families' stories about how helpful Early Intervention has been for them!
  - iii. A Cedarville University social work student concluded her junior placement with the EI program at the end of March. Pam interviewed five potential senior social work students for the upcoming school year; however, final decisions have not yet been made. Pam received approval from the Department of Children and Youth (DCY)





confirming that senior interns with 60 college credit hours can become credentialed Early Intervention Specialists (EISCs). The plan is to utilize this resource to expand the Early Intervention workforce in preparation for upcoming retirements over the next few years.

- iv. The EI program submitted supporting documentation to DCY for TRS compliance monitoring. County results will be distributed in June.
