1. Foundational Capabilities

a. Administration

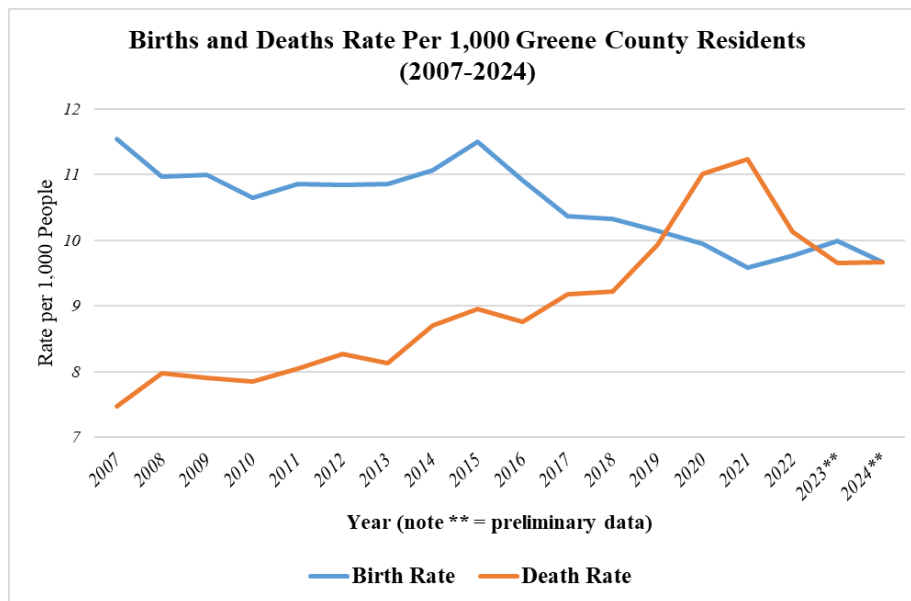
- i. Mid-May is the typical peak season for the common cold caused by rhinovirus and enteroviruses. The increases will usually decline just before the summer months. Additionally, pollen is also surging, triggering allergy symptoms. According to the [American Lung Association](#), you will know if your symptoms are allergies or illness by removing yourself from the source of allergens.
- ii. Bills for review to now be included in the monthly activity report are:
 - i. [HB 10](#) (Klopfenstein, Daniels) Regulate imitation meat and egg products in school lunches so that no lab meat is included in school lunches. In House Agriculture Committee.
 - ii. [HB 28](#) (Mathews, Hall) Eliminate the authority to levy replacement property tax levies. The bill mandates that all ballot questions related to tax levies exceeding the ten-mill limitation be presented clearly, with specific formatting, and removes the option to renew or replace taxes for current operating expenses or permanent improvements from the Senate Ways and Means Committee. Legislation is co-sponsored by Representative Dean and Representative Brian Lampton.
 - iii. [HB 57](#) (Jarrells, Williams) Regards school policies on administering overdose reversal drugs, including safety, security, training, and storage. Schools can accept monetary donations to support but do not specify partnering with local health districts to provide Narcan through existing supplies. Provides district and parent notification, and schools would need to report trends in use. It would be helpful to provide notification to health districts. The bill is in the Senate Education Committee.
 - iv. [HB 126](#) (Mathews A., Craig) Prohibit certain public nuisance actions. Legislation is in regard to the marketing and distribution of opioids and lawsuits filed against pharmaceutical companies. The bill is in the Senate Judiciary Committee.
 - v. [HB 137](#) (Lorenz) Permit tax authority to decline to submit certain levies to voters. Health districts and libraries have levies approved by the County Commissioners as taxing authorities, and this legislation changes the language from “shall” to “may” place a levy on the ballot. Since health districts receive no funding from County Commissioners, the Commissioners could hear the request and decline to place a health district or library levy on the ballot. In House Local Government committee with no co-sponsors.

- vi. [HB 160](#) Liquor and Cannabis (Stewart, B.) To revise specified provisions of the liquor control, hemp, and adult-use marijuana laws and to levy taxes on marijuana. The bill is currently in the House Judiciary Committee.
- vii. [HB 162](#) Medical Records (Click, G) Relates to medical records of minors and to name the act the My Child-My Chart Act. The bill is in the House Health Committee.
- viii. [HB 182](#) Public Water Systems (Dean, L) To prohibit a public water system from adding fluoride to its water. The bill is in the House Natural Resources Committee.
- ix. [HB 198](#) Hemp (Fischer, T) To regulate the manufacture, distribution, and sale of inhalable and ingestible hemp products. Representative Dean is a co-sponsor of the bill as it is in the House Judiciary Committee.
- x. [HB 215](#) Property Tax Levies (Jarrells, D, Stephens, J) The bill is in the House Ways and Means Committee and prohibits most property tax levies submitted at a general election from taking effect in the current year.
- xi. [SB 69](#) (Romanchuk) Intends to reform the state's public retirement system law. In Senate Financial Institutions, Insurance and Technology Committee.
- xii. [SB 78](#) (Hicks-Hudson, DeMora) Establish and operate the Ohio Health Care Plan – universal health care. The bill is in the Senate Financial Institutions, Insurance and Technology Committee.
- xiii. [SB 86](#) (Huffman, Wilkin) Regulates and taxes intoxicating hemp, a drinkable cannabinoid product. Senator Koehler is a co-sponsor, and the bill is in the Senate General Government Committee.
- xiv. [SB147](#) (Reineke) Revise solid waste and construction and demolition debris laws that govern the transfer and disposal of solid waste and construction and demolition debris. The changes provide procedures for withdrawing from a joint solid waste district. It has passed the Senate and was introduced in the House.
- xv. [SB 161](#) SNAP (Schaffer Johnson) To require the Director of Job and Family Services to seek permission to exclude certain items from the Supplemental Nutrition Assistance Program. This bill would require the Director to seek a waiver to exclude “junk food” from SNAP benefits. A similar provision was included in the budget to require JFS to seek a waiver to exclude sugar-sweetened beverages.
- xvi. [SB 166](#) Health Insurers (Manning) to prohibit fees for electronic claims submission by health insurers and the Medicaid program.

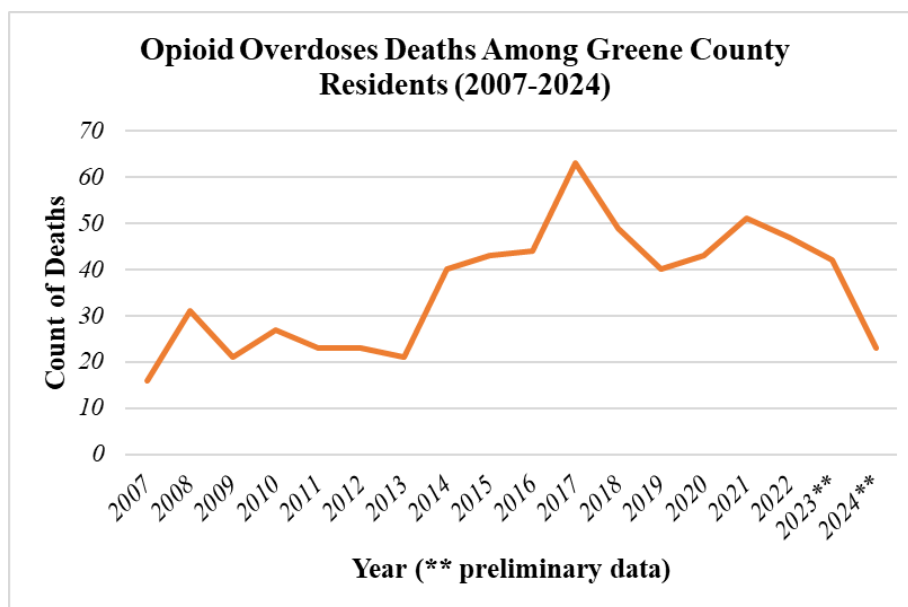
b. *Epidemiology*

- i. From 2007 to 2024, Greene County experienced a steady decline in birth rates alongside a rise in death rates. Initially, birth rates outpaced death rates,

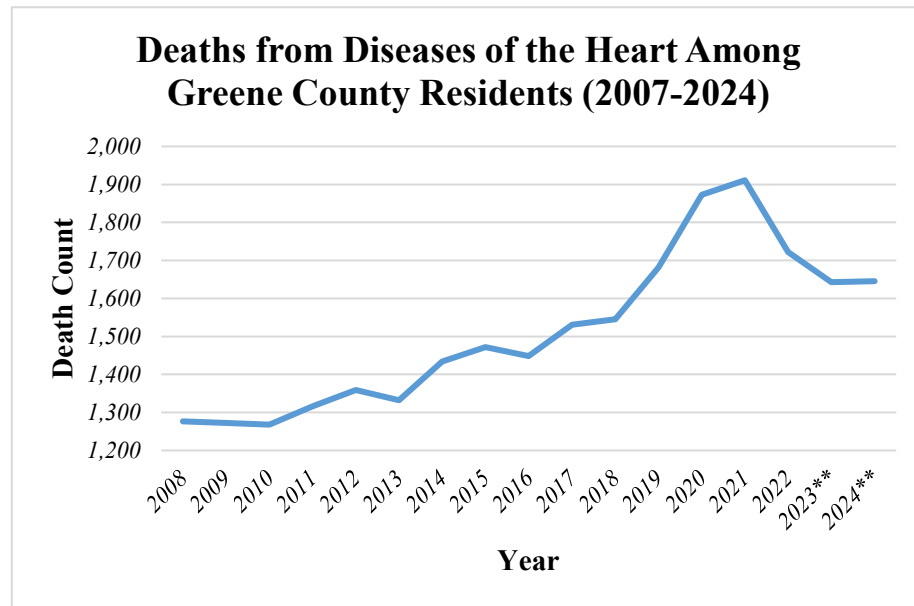
supporting population growth. However, this trend reversed in 2020, largely due to the spike in mortality caused by the COVID-19 pandemic. As the county's median age increases, a higher death rate and fewer births are natural demographic consequences. Additionally, other public health crises—particularly the opioid epidemic—have contributed to elevated death rates across Ohio counties, including Greene.



- ii. Opioid-related deaths in Greene County, Ohio, increased by an average of 2.8 deaths per year from 2007 through 2019, totaling approximately 441 deaths during that period. While the opioid epidemic had a substantial impact on mortality, it does not fully explain the overall rise in death rates.



- iii. Overall, chronic diseases, like heart disease, have been declining or are stable. The biggest risk factors for chronic diseases are a nutrient-poor diet, influenced by a person's reliance on nutrient-poor convenience foods and ultra-processed foods, as well as community infrastructure elements such as barriers to receiving early medical care and transportation needs. The [2024 Community Health Improvement Plan Annual Report](#) helps the community understand all of the effort that goes into making Greene County healthier. Heart disease remains the leading cause of death in Greene County. Heart disease increased by 17 deaths per year from 2017 to 2019. Demographic factors—such as an aging population and an influx of new residents moving into the county—likely played a larger role in shifting the balance between births and deaths, contributing to the county's broader population dynamics. The birth and death trends observed in Greene County are similar to those in Ohio's overall trends. Prevent heart disease by staying active, eating healthy, managing stress, avoiding tobacco, and regularly checking your blood pressure and cholesterol.

b. Emergency Preparedness

- i. Public Health Emergency Preparedness (PHEP) FY25 Grant Update:
 1. Seventeen out of eighteen deliverables are complete and approved.
 2. Sixteen out of eighteen deliverables paid, \$110,875.00 out of \$121,841.00.
 3. One deliverable was approved for billing in June for \$6,092.00.
 4. One deliverable left to be submitted by June 30, 2025.

3. Environmental Health (EH)

a. Food Establishment/Food Service

- i. The next ServSafe course will be taught in June 16 and 23, 2025, by A. Glascoe and M. Straight. This class is full, with 23 students and one retest registered to attend.
- ii. To date, 31 plans for brick-and-mortar food operations and mobile food operations have been submitted. R. Schairbaum, M. Fischer, and E. Mohr are the reviewers of these plans.
- iii. GCPH received the Ohio Department of Agriculture (ODA) Retail Food Establishment survey report. General Services will provide responses to the survey report, which will include action plans. More information will be provided in the June Monthly Activity Report.
- iv. The following festivals were inspected since last month's Monthly Activity Report: WSU April Craze, Vintage Market Days, Bellbrook Sugar Maple Festival, World A'Fair, Food Truck Mania (Hobson Park), Hamvention, and single temporary license events.

b. Mosquito

- i. The mosquito drone was delivered, and J. Marks and D. Shontz are working to get the drone ready for the upcoming mosquito season.
- ii. Through funding from the 2025 Mosquito Control Grant, Ms. Katy Rich was hired as a temporary contract employee for the mosquito program.
- iii. C. Kessler and D. Shontz calibrated the adulticide truck sprayers in Groveport, Ohio on May 20, 2025.

c. Sewage

- i. The Water Pollution Control Loan Fund (WPCLF) already has projects lined up, and one project was carried over to this year because all available funds were utilized last year. There is \$150,000 available for the 2024-25 program year.

4. Health Education

a. Creating Health Communities (CHC)

- i. L. Gonyer attended the Food Systems Coordinators Across Ohio meeting on May 7, 2025 with ODH to discuss food system efforts taking place across the state.
- ii. The Xenia Farmers' Market vendor orientation was held on May 14 and May 15, 2025 to discuss logistics for smooth market days.
- iii. J. Drew and L. Gonyer attended the Food and Farm Workgroup meeting on May 21, 2025 with B-W Greenway.

 - iii. The Harm Reduction Team tabled at Bridges of Hope, providing educational materials and resources, as well as testing for Human Immunodeficiency Virus (HIV), Hepatitis C (HCV), and Syphilis on May 14, 2025.
 - iv. K. Warren tabled at Greene County FISH Food Pantry on May 15, 2025, and passed out naloxone, educational materials, and local resource information to the community.
 - v. C. Holley-Wolf attending Blessing of the Bikes at Kil-Kare Raceway, passing out resources and naloxone on May 18, 2025.
 - vi. On May 22, 2025, the Harm Reduction Team took the mobile unit to Sugar Tree Ministries in Clinton County to distribute naloxone, educational materials, and local resources. The Mobile Health Unit was paid for with OneOhio Recovery Foundation grant dollars.
 - vii. K. Warren presented data and harm reduction material to the Wright State Addiction Medicine Fellows on May 28, 2025.
- c. *Safe Communities*
 - i. The ThinkFast Interactive program was held on May 2, 2025, at Xenia High School.
 - ii. L. Gonyer attended the Fairborn FISH Health Fair on May 6, 2025.
 - iii. L. Gonyer attended the Beavercreek Coffee with a Cop on May 13, 2025, at the Target in Beavercreek.
 - iv. L. Gonyer met with Central State University on May 13, 2025, to plan the 2025 Mocktail Challenge.
 - v. The Greene County Safe Communities Coalition hosted the *Click It or Ticket* kickoff event on May 14, 2025. The event consisted of a press conference featuring speaker Lt. Weeks of the OSHP, who discussed the importance of seatbelt usage. Following the press conference, the coalition had a photo opportunity with law enforcement vehicles.
 - vi. J. Drew and L. Gonyer attended the YMCA Health Fair on May 17, 2025.
 - vii. L. Gonyer attended Blessing of the Bikes on May 18, 2025.
 - viii. L. Gonyer attended the Ohio Traffic Safety Summit in Columbus on May 19 through May 20, 2025.
 - ix. The Safe Communities site visit took place on May 29, 2025.
 - x. Less than five scholarships remain through the Greene County Drive to Succeed program.

5. **Maternal Child Health (MCH)**

- a. *Complex Medical Help (CMH)*
 - i. CMH nurses are working with the Soin Medicine Residency and Community Outreach Program, educating them on GCPH programs and working with the Ohio Department of Health (ODH) CMH Field Nurse Case Manager to educate them on becoming CMH providers.

- ii. S. Sanders participated in the Soin Family Medicine Residency and Community Outreach Program on May 2, 2025.
 - iii. N. Kessinger and K. Ward visited Hannah's Treasure Chest at their new location in Miamisburg and toured the facility on May 19, 2025.
- b. *Communicable Disease & Tuberculosis (TB)*
 - i. GCPH is working to implement eClinicalWorks (ECW).
- c. *Early Childhood Home Visiting*
 - i. There is one Nurse-Family Partnership (NFP) Public Health Nurse position open and posted. Interviews are currently being scheduled.
 - ii. On May 6, 2025, we welcomed Ms. Kamri Ward, an intern from Wright State University, who will be completing 400 hours with us. She is working on a project primarily for the Healthy Families America (HFA) Team; however, she has an interest in all areas and is learning about Public Health. Kamri has already spent time with C. Holley at Safe Trade – her WSU program is in Health and Rehabilitation Services, and she has completed a course on harm reduction. Kamri has observed team members visiting families to assist in the project she is working on.
 - iii. On May 16, 2025, N. Kessinger and K. Ward participated in the USO Special Delivery Baby Shower at Wright Patterson Air Force Base.
- d. *Early Intervention (EI)*
 - i. Most of the Early Intervention Service Coordinators (EISC) participated in training by the Division for Early Childhood (DEC) called Service Coordination Virtual Institute. This was one of the best training courses we have attended, as it gave EISC staff the opportunity to be heard and recognized on a larger scale for all the work they do. The experience was both encouraging and informative, and we hope it becomes an annual event!
 - ii. P. Hamer submitted a project to the Quality Improvement (QI) team with the hopes of improving new referral assignments and Primary Service Provider (PSP) teams. The goal is to balance overall caseloads and enhance the PSP teaming process. This project will be a collaboration with the County Board of Developmental Disabilities/Four Oaks.
 - iii. The program has seen an increase in feeding concerns this month, which has led to an increase in referrals to a state contract provider, Glow Bright, for direct services for speech and occupational therapies.
 - iv. The State Fiscal Year (SFY) 26 EI grant was received from the Department of Children and Youth (DCY), which included allocations by county. A new item in this year's grant, as mentioned last month, is a designated amount to be offered to the local County Board of Developmental Disabilities (CBDD) to assist with evaluation and assessments. If CBDD accepts, GCPH will enter a contract with CBDD for these funds. The overall allocation for service coordination decreased from SFY25. This is due to a decrease in the number of new referrals received and the number of children served. Compared to the state's EI numbers, the numbers also decreased.
