GREENE COUNTY PUBLIC HEALTH MONTHLY ACTIVITY REPORT June 23, 2025

1. Foundational Capabilities

a. Administration

- i. Leadership meeting (05/29) had Scott Dehart discussing internal promotions, legal succession, equality in performance, and discipline.
- ii. The site visit report for Accreditation was received, with everything largely or fully demonstrated. One item in Quality Improvement/Performance Management was slightly demonstrated. We will probably hear something back in August 2025.
- iii. The Public Health Emergency Preparedness Program (PHEP) grant has been reduced by 28% remaining fully funded through March 31, 2026. Funding beyond this date is unknown.
- iv. The Advisory Committee on Immunization Practices met to discuss and vote on specific recommendations for influenza, Covid-19 and Respiratory Syncytial Virus (RSV) vaccines in time for seasonal viruses. The full [recommendations and concerns](#) from the public health and medical community were circulated following the meeting. A new RSV monoclonal antibody called nirsevimab was approved. The committee recommended single dose influenza vaccine following a presentation on [thimerosal](#). [Key points](#) to remember in vaccine safety are :

Key Points

- All vaccines routinely recommended for children 6 years of age and younger in the U.S. are available in formulations that do not contain thimerosal.
- Vaccines that do not contain thimerosal as a preservative are also available for adolescents and adults.
- A robust body of peer-reviewed scientific studies conducted in the U.S. and other countries support the safety of thimerosal-containing vaccines.
- Preservatives prevent microbial growth.
- The use of thimerosal as a preservative in vaccines has markedly declined due to reformulation and development of vaccines supplied in single-use presentations.

- v. We received a cease letter from Public Health Dayton and Montgomery County to stop working on the HIV grant. The federal government has not issued Notices of Award for budget periods beginning July 1, 2025.
- b. HB96 (State Budget Bill) with line-item vetoes was signed by Governor Mike DeWine on June 30th.

b. Emergency Preparedness

- i. Medical Reserve Corps was asked to set up a first aid station at the Yellow Springs PRIDE festival on June 28th.
- ii. PHEP FY25 Grant Update:
 - a. 18/18 Deliverables complete and approved.
 - b. 16/18 Deliverables paid \$110,875/\$121,841.
 - c. One deliverable billed in June for \$6,092.00.
 - d. One deliverable approved to bill in July for \$4874.00.
- iii. The 2026 PHEP Grant will have a 28% cut (\$34,115.48). The grant should be \$87,725.52 and will be fully funded for nine months. We are waiting on the new NOA and deliverable requirements. The Ohio Department of Health (ODH) stated that the Centers for Disease Control and Prevention (CDC) should also fully fund the last three months, and we will receive deliverables for that timeframe.

3. Environmental Health

a. Food Establishment/Food Service

- i. R. Schairbaum and M. Straight taught a ServSafe course on June 5th and 12th for nine individuals and one student who was retested. To date, GCPH has conducted two food training courses for a total of 17 students, one proctored exam session for one student, and three retests.
- ii. As of May 31st, the General Services team completed 1,137 inspections on RC I-IV facilities, 47 inspections for in-count food mobiles, and 69 consultations for out-of-county food mobiles. The team has also inspected/issued 57 temporary food licenses.
- iii. The following festivals were inspected since last month's Board of Health report: Stronger Together Concert, Creek Classic, Yellow Springs Street Fair, Jamestown Street Fair, and single temporary license events.

b. Mosquito

- i. J. Marks and D. Shontz have been working to prepare the mosquito drone for this season. Practice flights were flown to get used to the controller and the flight characteristics of the drone.
- ii. J. Marks spent time training the new mosquito intern. Having an intern has really helped with trapping, complaints, and some applications of larvicide.

c. Sewage

- i. The sewage program has seen an increase in site reviews in the last two weeks. Installations should increase as the weather gets drier.
- ii. We are working on four Water Pollution Control Loan Fund projects and have just approved another project.

d. Solid Waste

- i. Second quarter solid waste inspections are done.

- e. *Swimming Pools/Spas*
 - i. All Greene County operating swimming pools/spas have been licensed for the 2024 licensure year. All delinquent swimming pools/spas were charged the 25% penalty fee for late licensure. The team has been extremely busy conducting swimming pool/spa opening inspections for the new season.

4. **Health Education**

- a. *Creating Healthy Communities (CHC)*
 - i. In conjunction with the City of Fairborn, the Active Transportation Plan was presented to the Fairborn Planning Board on June 10th before going before the Fairborn City Council. The Active Transportation Plan will be presented to the city council on July 7th.
 - ii. L. Fox was interviewed by Dayton 24/7 Now regarding the Xenia Farmers' Market.
 - iii. The Xenia Farmers' Market kicked off on Wednesday, June 18th at 4 pm. The market will take place on the third Wednesday of June through September from 4-7 pm.
 - iv. The Greene County Food Council met on June 26th and discussed goals and objectives for the group, including, but not limited to, addressing dietary needs in food pantries, reducing food waste, stocking local little pantries, and collaborating with master gardeners to offer workshops.

- iii. Greene County Public Health's Drive to Succeed program has successfully awarded thirty driver's education scholarships to local high school students. This means the program has reached capacity unless a recipient drops out of the driving school.
- d. *Tobacco*
 - i. Concluded second cessation media campaign of the grant year with a net reach of over 118,000 people.
 - ii. TU25 Tobacco Use Prevention and Cessation Grant Solicitation concluded June 30th.
 - iii. K. Warren attended the Employee Wellness event at Leonardo DRS in Beavercreek on June 11th to provide tobacco cessation information with GCPH promotional materials, general health education materials, and other resources.

5. **Maternal Child Health (MCH)**

- a. *Communicable Disease & TB*
 - i. GCPH is now a part of a health information exchange known as CliniSync. There are 151 Ohio hospitals connected to CliniSync. This will improve and expedite coordination of patient care.
- b. *Early Childhood Home Visiting (ECHV)*
 - i. All team members have a full or nearly full caseload. There is no waitlist, and new families are currently being accepted.
 - ii. I. Barnett, C. Manor, and T. Sparks have all completed the Growing Great Kids (GGK) Preschool training. This allows us to serve families for a full three years according to the Ohio Revised Code, up to the age of five.
- c. *Early Intervention (EI)*
 - i. The service coordinators worked diligently over the last eight months, tracking and monitoring timelines for Timely Receipt of Services (TRS) compliance. This is the requirement where 100% of the services must be delivered within 30 days of the signed Family Service Plan. We received a rating of 100 percent. Congratulations to our team!
- d. *Family Connects*
 - i. Central Intake is working on Memorandum of Understandings (MOU) with area hospitals to receive automatic referrals to the Family Connects program.
 - ii. A Soin Family resident attended a home visit with S. Sanders on June 17th.
- e. *HIV*
 - i. An HIV testing and educational event was held at Antioch University with S. Webb and K. Ward on June 5th.
 - ii. S. Webb attended the Fairborn PRIDE event and provided HIV testing and education on June 21st.
 - iii. National HIV Testing Day is June 27th. The Greene County Public Health mobile unit will be at Walgreens in Xenia to offer free HIV testing, counseling and referral services.
